

Ministry of Labor and Social Affairs (MOLSA) Monitoring and Evaluation (M&E) Capacity Strengthening Action Plan for Anti-Trafficking and Women's Issues Division and **M&E Division**

This monitoring and evaluation (M&E) Capacity Strengthening Action Plan outlines a response to the key M&E capacity gaps identified among MOLSA divisions. The recommendations from a capacity assessment with multiple components were used to propose activities that MOLSA and its partners may wish to undertake to improve the M&E capacities of MOLSA staff and the two divisions that support monitoring and evaluation of Counter-Trafficking in Persons (C-TIP) interventions. The two divisions are the Division of Anti-Trafficking and Women's Issues and the Division of Monitoring and Evaluation.

The activities included in this plan are aimed at improving skills, tools, and processes that would make MOLSA C-TIP efforts more targeted and contribute to cooperation and coordination for improved case referral, assumed victim¹ identification, victim support services, and transparency and accountability in policymaking. The plan also contains practical measures to improve coordination and communication among the MOLSA, other government agencies, nongovernmental organizations (NGOs) working in the field, and international partners who play complementary and supporting roles.

To leverage and increase the efforts and ongoing reform in M&E, the following aspects were identified using a strengths-based approach, and the assessment grouped these strengths into categories depending on the level of need and planned intervention:

- Responsiveness and commitment at the organizational level: The MOLSA divisions are committed to improvement of C-TIP activities through evidence-based approaches.
- Targeted renewed approach to M&E by MOLSA and the government overall, considering the finalization and approval of the MOLSA methodology on M&E:2 The procedure for M&E of the program in the MOLSA indicates that the government is committed to standardizing the methodology used to evaluate programs and production of management reports that will be used to provide progress made by the entity in achieving institutional commitments.
- Teamwork and inter-agency strong connection among C-TIP Working Group (WG) members such that implementation of the National Action Plan is completed by each stakeholder.

¹ The term "victim" is used throughout to maintain consistency with Armenian C-TIP reports. The term may be considered more inclusive when discussing services provided for individuals who may not have survived (for example, "victim identification"). However, alternative terms like "survivor" are preferred and used in certain contexts.

² Procedure for Monitoring and Evaluation of Programs (Provided Services) Implemented in the Social Protection Sector (Minister of Labor and Social Affairs, 2022)

• Learning: The C-TIP implementation progress is used in reporting government performance to the national forums (Inter-Ministerial Council) and the regional forums such as the Council of Europe's Group of Experts on Action against Trafficking in Human Beings (GRETA) amongst others.

Enhancing M&E capacities will support sustainability in data collection, analysis, and use for program and policy improvement. It is also important to bring on board the Statistical Committee for the Republic of Armenia because of its role in data management and dissemination of information.

Strengthening C-TIP M&E capacities in the MOLSA will result in:

- Acquisition of skills by key country stakeholders and expansion of in-country capacity.
- Greater collaboration and learning within the MOLSA divisions, between C-TIP implementing agencies, and with development partners and the national government.
- Increased quality of data to support broader national policy development and overall C-TIP programming.


